NOTIFICATION

In exercise of the powers conferred by section 200 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with section 21 of the General Clauses Act, 1897 the Government of Karnataka hereby amend the Notification No. TRD 309 SAEPA 2006, Bangalore, dated:29th October, 2007 published on 12-10-2007 in part-IV-A No. 1879 of the Karnataka Gazette as specified below:-
